On September 5, the Compact Office issued a <u>notice of publication and comment</u> regarding the new Group Whole Life Uniform Standards. Ten uniform standards are under consideration and have been published on the <u>Docket Developing Standards page</u> of the <u>Insurance Compact's website</u>. COMMITTEE UPDATES

PRODUCT STANDARDS COMMITTEE

The Product Standards Committee (PSC) is working towards finalizing amendments to the Group Term Life Insurance Uniform Standards for non-employer groups. A public call will be held to receive written and oral comments on the draft amendments in the coming weeks.

The PSC is also working on the 2024 Priority List for Uniform Standards Development. The group held a public call on August 29 to receive written and oral comments. The 2024 Annual Identification Requests for Uniform Standards Development is available on the PSC page on the Insurance Compact's website.

FINANCE COMMITTEE

The Finance Committee met Wednesday, September 6 in a regulator-only meeting to receive an update on the Compact's financial condition and to review the draft 2024 annual budget. The draft budget was also presented during a public Finance Committee call on Wednesday, September 27; the Finance Committee will now refer its recommendation to the Management Committee to expose the budget for a public comment period. The budget will then be considered for adoption during the Insurance Compact's next in-person Annual Meeting scheduled for December 3 in Orlando, FL.

INDEX-LINKED VARIABLE ANNUITY SUBGROUP

The Index-Linked Variable Annuity (ILVA) Subaroup released its latest draft of Index-Linked Variable the Annuity Uniform Standards on July 12 and issued a request for feedback from industry representatives and interested parties. The Compact Office asked for written comments by early September, and comments have been submitted by the American Academy of Actuaries (AAA), Insured Retirement Institute (IRI), American Council of Life Insurers (ACLI), and the Committee of Annuity Insurers (CAI). The subgroup expects to meet in the near future to review the submitted comments. You can follow the work of this subgroup and view the comments on the PSC webpage under "Exposure Drafts."


Thursday, October 5th at 3:30 pm ET / 2:30 pm CT

Tuesday, October 10th at 1:30 pm ET / 12:30 pm CT


