2. Overview of the Committee's Activities

EXPLANATION: The Adjunct Services Committee will report on its activities including implementing enhanced training and communication between the Compact Office and Compacting States; surveying states on their processes to review innovative features; and the outline of a collaborative pilot process to bring the states together utilizing the Compact to streamline state-by-state review of products and benefit features within the Compact product lines but outside scope of Uniform Standards.

3. Presentation of the "Innovation Office" Framework and Pre-Filing Questionnaire for Feedback/ Comments

EXPLANATION: The Adjunct Services Committee will present a Framework with key steps for an "Innovation Office" that would facilitate the Compact Office platform and expertise to streamline consideration by states of a product or benefit feature that is not able to be submitted to the Compact but fits within the Compact's authorized product lines. The Committee developed a draft Pre-Filing Questionnaire that would be completed by a company/filer as part of the consideration process. The Committee is asking all interested parties to review and provide comments on the Framework and Pre-Filing Questionnaire. The Committee is seeking comments or suggestions to ensure the process protects consumers, preserves state authority on whether or not to accept or allow the product or benefit feature in their state, and offers efficiencies for filing companies.
