3. Finalize recommendation on the framework and operating procedure regarding the use of Compact-approved products for non-employer groups

EXPLANATION: The goal is for the Committee to finalize its recommendation to the Management Committee with respect to the framework and draft operating procedure. Committee members are requested to review the draft recommendation memorandum and the proposed Operating Procedure for the Use of Compact-Approved Products for Other than Employer Groups for purposes of making final edits. Upon recommendation to the Management Committee, this recommendation will be subject to a formal rulemaking period of 60-day notice and comment and public hearing before it is considered by the Management Committee and Commission for adoption later this year.

4. Observations and discussion on the uses of mix and match and regulator concerns

EXPLANATION: Based on analysis of the uses of mix and match in 2021 Compact filings, the Compact Office has provided a description and example of the reasons for uses of mix and match. The Committee will discuss these reasons and other reasons and examples provided by Compact regulators.

5. Discussion of mix and match survey questions for regulators and company filers

The Committee will review draft questions for a new regulator survey and a filer survey and provide input. Committee members are requested to review the proposed survey questions.
